Refund and Cancellation Policy

All cancellations must be in writing via fax, e-mail, mail or in person. Cancellations received five (5) days or more prior to the start of a course will be assessed the \$75 non-refundable deposit fee. Cancellations received less than five (5) days prior to the start of a course; NO REFUND is applicable. Students may enroll in another class within six (6) months by paying a \$25 transfer fee. After six (6) months students forfeit their tuition. NO REFUNDS will be given for retake or reinstate students. The academy requires a \$75 non-refundable deposit with your application. If you are a "no show" for a course NO REFUND is applicable. We reserve the right to cancel or reschedule any class session (s), at any time, for any reason. Students will be notified about a make up class. Students who can't attend the make up class will have the option of transferring to another class or home study within six(6) months of the original enrollment, no refund and no additional fees will apply. We reserve the right to cancel, substitute or reschedule any instructor for any reason without notice.

Attendance & Completion

Each student is required to complete 45 hrs of training. You are allowed to miss one (1) 3.5 hour session. However, it is required that those hrs. be made up before you can receive your transcript. Missing two (2) 3.5 hour sessions will result in being dropped from the class and you will need to register for a new class at the retake fee. Saturday classes count as two (2) 3.5 hour sessions.

You will be issued an Original Uniform Transcript upon successful completion of the school's final exam. Replacement fee for lost or duplicate transcripts is \$25.

75% is the passing score on each portion of the final exam. Students who score between 74% and 60% and those who do not test with their original class must retake the final exam for a fee of \$25.

Students who score below 60% are REQUIRED to repeat the course, and may do so for a fee of \$99 within 6 months of their original beginning date. Students who do not complete the course may repeat the course for a fee of \$99 within the 6 months of their original beginning date. After 6 months, but prior to 1 year a student can reinstate for a fee of \$210. After 1 year, the student must register as a new student.
